ACCURATE & EFFICIENT CONTROLS

With Varonis DataPrivilege data users, authorizers, owners and reviewers interact within a single application and web-based user interface for the purpose of requesting approving and monitoring data access entitlements. Data business owners can define rules for who should approve entitlements to certain data sets. Users can initiate and track access requests and data authorizers can review and grant as appropriate. DataPrivilege will notify all parties via email when a request has been acted on.



ACCOUNTABILITY & CONTINUOUS AUDIT

Because some data is extremely sensitive or may fall under strict regulations for handling, it is often necessary that data authorizations be reviewed and approved by third parties, such as legal or financial groups, compliance officers or executive staff. DataPrivilege authorization review makes it possible to establish additional sets of controls via tiers of data reviewers and authorizers further ensuring data access accountability and transparency.
